

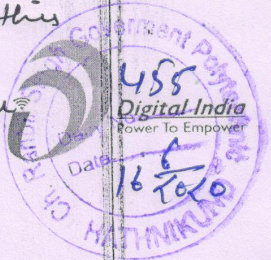

The Pharmacy institutions, faculty, and working pharmacists may explore how with their knowledge and skill they can assist the local health authorities in this national emergency by creating awareness, supporting physicians, counselling patients and many more ways that may be applicable in your region.
